## **MEDIA ACCREDITATION IMPORTANT INFORMATION:**

### **ELIGIBILITY FOR MEDIA ACCREDITATION:**

- Media Accreditation is for editorial staff covering the event. Unfortunately due to high demand for tickets it is not possible to provide accreditation for non-editorial staff e.g. sales/support staff. - This accreditation is valid for a single person only; each journalist/photographer attending must complete a form.
- Although we endeavour to provide tickets to all journalists requesting accreditation, due to high demand it is not always possible to guarantee this.

### **ACCREDITATION DEADLINE:**

- Forms received after the deadline of **10 October 2014** will only be eligible for contingency tickets – if at all. Advance accreditation is essential to attend the event.

### **COLLECTION OF ACCREDITATION AND TICKETS:**

Photographers will have access to the photography area but will not be provided with seating - unless requested by the 10<sup>th</sup> of October 2014.

### **PHOTOGRAPHERS:**

- Photographers from your publication must also fill in a form. Only one (1) photographer per publication will be allowed to photograph the show. Photographers will gain access into the venue however seating will not be provided. Regrettably, partners cannot be accommodated.
- Photographers will be allowed to photograph the duration of the event from the designated areas.
- Photographs are strictly limited to use in the publication indicated on the form and are not for use in any commercial / sale venture.
- Photographers are to report to the Loftus Ticket office outside the venue at least 30 minutes prior to the performance start. Late arrivals will not be admitted into the venue.
- On a case by case basis, Monster Energy and Motorsport South Africa shall be entitled to reasonably request access to images for use and reproduction, free of charge, worldwide and for the duration of protection by applicable intellectual property law, any photographs/images captured by the Accredited Party for non-commercial purposes.
